Upgrade now as nothing will be offered after the January rollout. Everything will now be run through the Digital Coaching Center ([doc.usoccer.com](http://doc.usoccer.com)). Must have "F" license before any other. US Soccer only recognizes licenses or other "equivalents" from FIFA sanctioned bodies. No waivers unless granted by USSF. Must have Professional or International playing experience. (FLPP Waiver Application) A waiver is not a license. The database at the digital coaching center only goes back 25 years. License information: F license U6-U8 (\$25) is online, 2 hours, prerequisite; E license U9-U12 (\$135); D license U13-U14 (\$270) this is a split schedule course requiring early registration. C license is regional.
